Member and Guest Code of Conduct

Introduction

The intention of this document is to establish clear and acceptable behavior expectations from all members and guests at Sapphire National Golf Club. It is not intended to restrict the rights of anyone but rather to ensure that all members and guests can expect to be treated with respect while enjoying the Sapphire National Golf Club course and clubhouse.

The club deems that upon payment of membership or green fees, all members and guests have given their consent to be bound by both the restrictions and penalties imposed by this code of conduct.

Code of Conduct

All members and guests will:

- ❖ Conduct themselves in a sportsmanlike manner including refraining from profane language, gestures, insults or other such misbehavior and will not knowingly cheat, throw clubs, disrespect employees, officials or fellow competitors
- ❖ Respect the rights of other players and golf course staff by abstaining from verbally or physically threatening or slandering others, either personally or through social media
- ❖ Not engage in any form of sexual, racial, religious discrimination or harassment
- ❖ Adhere to the dress code and observe proper golf etiquette as well as USGA and local rules of the course, such as following cart signs, or not keeping carts away from greens at all times
- ❖ Respect the golf course, golf carts and facilities
- ❖ Adhere to all club rules (non-all inclusive list below)
 - Sign in procedures in the Golf Shop
 - Rental and safe operation of carts in designated areas only
 - Seeking staff approval for starting on hole number 10
 - Obeying all signage on the golf course
 - Take pride in the physical appearance of the Sapphire National Golf Club as it is a reflection of you as a member
- ❖ Abide by all state and local laws and regulations, including the possession of any illegal drugs and weapons on the property of the Sapphire National Golf Club
- ❖ Be an ambassador for the Sapphire National Golf Club when out in the community or at other clubs, we are all representatives of Sapphire National Golf Club

Resolution of violations to the Sapphire National Golf Club Code of Conduct:

- ❖ **Golfers who violate this Code of Conduct will be asked by the Sapphire National Golf Club management staff to correct their behavior. If golfers continue to disobey the Code of Conduct, the individuals may be banned from the Sapphire National Golf Club and are subject to a temporary or complete loss of membership and playing privileges without a refund of any previously paid moneys**
- ❖ **In all cases should there be damage to property, monetary restitution will be mandatory to continue membership and penalties up to but not limited to legal proceedings**
